- A ranking sheet for each cost tier was provided to those voting members present. Members were encouraged to rank 'regionally.' Rankings were then collected and scored by Mrs. Holland.
- Ranked cost tiers were presented to the committee. The committee also decided the overall rankings. The top 4 projects in each tier were selected for this overall list.
- Jim McDannel made the motion to approve the tier and overall rankings as presented (attached). Mayor Rose Wolfe seconded the motion. Motion passed. The rankings will be presented to the KRADD Board of Directors May 25<sup>th</sup> to be approved. The approved rankings will then be submitted to the Highway District Offices and the Transportation Cabinet.
