# **BUSINESS**

# (1) Program Updates:

- (A) Ms. Stacie Noble, Associate Director of Human Services, presented an update of programs under her leadership to the Board. A copy of which is included in the official record. Ms. Noble also reminded the Board and those in attendance regarding Senior Games which will be held in May.
- (B) Ms. Jennifer McIntosh, Associate Director of Community and Economic Development/ Water & Wastewater Planner, presented an update of programs under her leadership to the Board. A copy of which is included in the official record.
- (C) Ms. Tabitha Haddix, Community & Economic Development Planner, presented to the Board an update of programs under the leadership of Ms. Eunice Fitzpatrick Holland, Associate Director of Community and Economic Development/Transportation Planner. A copy of which is included in the official record.
- (2) Legislative Update: Ms. Michelle Allen, Executive Director, addressed the Board concerning the legislative update and what issues directly impact our counties and cities. Ms. Allen reported that HB 482 went through and this bill adds an additional \$2,000,000.00 to the joint funding agreement between the ADDS and DLG. This is the base funding that supports the CEDS department and had not had an increase since it's origination in the 1970s. Representative Chris Fugate sponsored this bill and it is extremely appreciated. There was also an additional \$250,000.00 for additional ARC match to pay for CEDS staff that ADDS receive directly. All counties will get a portion of the \$200,000,000.00 that is allocated with this HB 482. The Governor was very appreciative and complimentary of the ADDS. Ms. Allen thanked Mayor Thomas, Mayor DePriest, Judge Alexander, Mr. Jesse Riley, Ms. Eunice Holland, and Ms. Jennifer McIntosh for their input and presentations because they were instrumental in the \$200,000,000.00 being added to the budget for the ADDS and economic development.

Ms. Allen also reminded those in attendance to watch the Equity Training with Mr. Steve Jones which is part of our contract.

Ms. Allen informed those in attendance about the upcoming ADD Directors Training Retreat May 11, 12, and 13.

Also concerning the legislature update, Mr. Craig Lindon informed the Board regarding the increase to the transportation budget flex funds for resurfacing. Discretionary funding was lowered by \$10,000,000.00; currently having \$35,000,000.00 in requests. Therefore, discretionary funding does not look promising.

### **OTHER BUSINESS**

Ms. Andrea Begley, Field Representative, Congressman Hal Rogers, was in attendance and thanked those who came out in support of Congressman Rogers at Mine Made Adventure last night.

Ms. Begley also reminded everyone to let her know should any need letters of support for their projects. There will be a Focus SOAR Summit on entrepreneurship and innovation June 23<sup>rd</sup> and 24<sup>th</sup> in Hazard and reminded everyone interested to attend.

Mr. Tom Cravens, Director, Challenger Learning Center, was in attendance and provided copies of the Summer Camp 2022 Brochure and Schedule and thanked the Board for their continued sponsorship.
